3. All packages are extendable to 30 miles or 50 miles for an additional £10.00 or £22.00 respectively.
4. Any additional distances, time, prints, canvases etc. are at normal rates.

Terms and Conditions

Unless a business customer has agreed payment and or delivery terms in advance the following shall apply:

1. A minimum of 50% of the cost of photography, agreed mileage charges and or packages is payable 7 days in advance of the agreed session (photo shoot), with the balance payable at the end of the session, Sessions arranged less than 7 days in advance are payable in full at the time of booking.
2. Venue hire, model charges and any additional expenses are payable in full in advance of their booking by StudioTEQ and are non-refundable once StudioTEQ has booked the resource.
3. Any additional time requested and provided during the session is payable in full at the end of the session.
4. If the photographer is late attending an agreed session the client shall allow up to one hour for them to arrive, after such time the photographer is classified as unable to attend. Where possible, the client will be informed of the situation and progress.
5. If the photographer is unable to attend an agreed session, the session can be rearranged for a later date or time, or any monies paid shall be reimbursed, at the client's discretion.
6. If the client is late attending an agreed session the photographer will allow up to 15 minutes for them to arrive, after which period the client either agrees to pay for any additional time, reduces the session to fit in with the original time-frame or the session is cancelled and all monies paid in advance is forfeit.
7. If the client fails to attend an agreed session or cancels giving less than 24 hours notice all monies paid in advance is forfeit.
8. Online proofs are normally available within 7 working days of the session, but are provided on a best endeavours basis and may take up to 28 days, however the client will be informed of the situation and progress. Any urgent requirements will incur additional charges.
9. Printing, photo-finishing and other requests or requirements made after the session are payable in full at the time of ordering.
10. Delivery of prints, canvases etc. will be without charge and normally take 7 working days from the time of ordering, but is performed on a best endeavours basis and may take up to 28 days, however the client will be informed of the situation, progress and shipping, which may include more than one delivery. Any urgent requirements will incur additional charges.
11. The Copyright and ownership of the photographs or any part of taken during a session (photo shoot) remains entirely with StudioTEQ and they may not be sold, copied, enlarged, re-printed, transferred to a digital format, stored on an electronic device or displayed on a website without the express permission of StudioTEQ.
12. StudioTEQ may utilise the photographs taken for advertising and marketing purposes, but will not sell the pictures to anyone without prior consent other than:
 - I. the client for business customers
 - II. the client, their friends and family for private customers (consumers).
